

## Terms and Conditions

The Terms and Conditions (T&C) apply to the buyer of the Rudrcoin (RC) and future user of the Rudrcoin platform. So before using our platform, you should carefully read the T&C, as well as the white paper of the Rudrcoin project.

### APPLICABILITY

The following T&C constitute the agreement (the "Agreement") between **DONJOP ONLINE SERVICES PVT. LTD.** (hereinafter "Rudrcoin" or the "Company"), An Indian Company CIN: U72300UP2015PTC071742, and you (the "User") with respect to the use to the purchase of the Rudrcoin and the future services offered through our platform. By using our services, you are agreeing to be bound by the T&C in its latest version. You are aware that Rudrcoin may change this T&C at any time. Your continued use of the Rudrcoin Platform means that you accept any new or modified terms.

### SERVICES

Rudrcoin is a blockchain based platform for innovators, researchers, developers and inventors for raise funding for research and development work and a platform to offer the online E-commerce service. Rudrcoin system will prove to be the perfect environment to give birth, nurture, and flourish an idea/concept into a real and viable product, to be used by consumers.

Rudrcoin is an Ecosystem to promote and nurture innovation & creativity, Cryptocurrency Trading Platform, Exchange, and the Marketplace to sell, buy, patents, copyrights, trademarks and products and services directly to investors, manufacturers and/or end user/s.

### THE RUDR COIN (RC)

- Ⓜ Rudrcoin functions as means of payment on our platform, which will allow future users to make use of our platform services.
- Ⓜ Through the coin sale, the future user acquires the future rights to use the Rudrcoin platform.
- Ⓜ Rudrcoin does not have the legal qualification as a security, since it does not give any rights on dividends or interest.

- ② RC is final and non-refundable.
- ② RC is not a share in our company and does not give any right to participate in the general meetings of our organization.
- ② RC will not have a particular value outside the Rudrcoin platform. The purchase of RC shall therefore not be done for speculative usage.
- ② Rudrcoin can be purchased during the coin-sale directly from the Rudrcoin website or after the coin-sale end at the Company or exchanger.
- ② Any future user purchasing RC expressly acknowledges and represents that she/he has carefully reviewed the T&C and fully understands the risks, costs and benefits associated with the Purchase of this coin as indicated in the T&C.

### KNOWLEDGE REQUIRED

- ② A future user undertaking to purchase RC in relation to the coin sale should ensure that she/he understands and has significant experience of cryptocurrencies, blockchain systems and services, and that she/he fully understands the risks associated with the coin sale as well as the mechanism related to the use of cryptocurrencies (incl. storage).
